The Board of Regents met at their Office on Tuesday, May 2, 1905, at 10 o'clock A.M. Present: W. W. Booher, Oscar J. Smith and H. S. Starrett.

Minutes of April 8 read and, with the following correction, approved:

The request of the young lady students of Manzanita Hall with reference to locating the new Dining Hall was granted and the Secretary of the Board was instructed to notify the Committee of the action of the Board.

President Stubbs read his report.

Upon motion of Regent Booher, seconded by Regent Starrett, the action of the Chairman of the Board and the President of the University in allowing the contractor \$375 extra on brick to be used in the Metallurgical Laboratory building, on account of the brick being a better quality and quicker delivery to the contractor, was approved.

Upon motion of Regent Starrett, seconded by Regent Booher, the Chairman and Secretary of the Board were authorized to advertise for bids in the Reno Evening Gazette, Nevada State Journal and the Nevada Observer for the Dining Hall building and porch for Manzanita Hall, both bids as per plans and specifications on file in the Regents' Office. Said bids to be opened at 3 o'clock P.M. Monday, May 29, 1905.

Upon motion of Regent Starrett, seconded by Regent Booher, the claim for the balance due on the Tri-Decennial publication of \$250 was ordered allowed and paid from the Contingency Fund.

Upon motion of Regent Booher, seconded by Regent Starrett, the Secretary of the Board was instructed to acknowledge the thanks and appreciation of the Regents for the general donation of Mr.

C. J. Cutts of Carson City, Nevada, of Two Hundred dollars a year for lectures to begin at the University on important social ques-

tions.
