# BOARD OF REGENTS BRIEFING PAPER

# Agenda Item Title: Request to Continue PERS retirees

## BACKGROUND & POLICY CONTEXT OF ISSUE:

On August 19, 2004, the Board approved UNLV's request for rehiring PERS retirees Michael Robison and Pamela Salazar due to their unique qualifications. Dr. Robison was hired through a search process where there were two qualified applicants; one took a position with another department. Dr. Salazar was hired after the initial search produced no acceptable candidates and the search was reopened at which time she was hired. Such hires are permitted, with Board approval, under legislation passed during the 2001 Legislature. The law (NRS 286.523) requires this action to be subject to review every two years. Both individuals work in the PK12 Education Leadership program. Dr. Robison was hired to cover masters level endorsement/degree courses to meet the shortage of CCSD Administrators and to allow full time tenure-track faculty to cover expanding doctoral level courses. Dr. Salazar was also hired to cover masters level endorsement/degree programs to meet the shortage of CCSD administrators and to provide professional development outreach activities for school leaders in Nevada. Both their background experiences as CCSD administrators continues to be essential to the successful implementation of the PK12 Education Leadership program. The shortage of qualified candidates is due to the rapid growth and fewer individuals willing to leave PK12 administration for higher education positions. These positions have been prioritized in the UNLV Strategic Plan.

## SPECIFIC ACTIONS BEING RECOMMENDED OR REQUESTED:

UNLV recommends that the Board reaffirm the action they took in August of 2004; this action would allow two PERS retirees—Michael Robison and Pamela Salazar—to continue their work at UNLV. The action is necessary because state law requires a review of this decision every two years.

### **IMPETUS (WHY NOW?):**

State law (NRS 286.523) requires the Board to review this decision every two years; the Board took action in August 2004. Action now will allow the individuals to continue to work at UNLV and continue to draw their PERS retirement.

## BULLET POINTS TO SUPPORT REQUEST/RECOMMENDATION:

- Both individuals work with CCSD to ensure successful implementation at the masters level PK12 Educational Leadership program.
- Both individuals are uniquely well qualified for their position; their experience as school district administrators is enormously helpful in implementation of successful programs through the Department of Educational Leadership

### POTENTIAL ARGUMENTS AGAINST THE REQUEST/RECOMMENDATION:

• Both individuals currently are retired through PERS.

## ALTERNATIVE(S) TO WHAT IS BEING REQUESTED/RECOMMENDED:

If the request were denied, the individuals would be required to either resign their positions at UNLV or discontinue their withdrawals from PERS. This could require the Department to search for other individuals to fill these critical roles.
