NOMINATION JUSTIFICATION—SAMUEL S. LIONEL

AFFILIATION WITH UNLV AND NSHE

Sam Lionel is a partner at Lionel Sawyer & Collins, one of the largest law firms in Nevada. The firm was founded in 1967 when Grant Sawyer ended his term as Governor of Nevada and joined with Lionel, a well-known litigator and business lawyer. In 1972, Jon Collins, a former Chief Justice of the Nevada Supreme Court joined the firm. In addition to being a founder of the firm, Lionel serves as President and is a member of the executive committee and the chairman of the litigation department.

Lionel earned battle commendations with the Army in North Africa and Italy in World War II. He went on to become a judge advocate general and to teach at West Point. He moved to Las Vegas on the advice of Emily Wanderer, Southern Nevada's first female attorney and made his mark in gaming law, corporate governance and litigation.

He is a long-time, major donor to the William S. Boyd School of Law, supporting student scholarships. He has been giving at President's Associate's level to the Annual Fund since 1988. To date, his gifts total more than \$754,000. He serves as a member of UNLV's Law School Dean's Executive Council. He served as legal counsel for Jerry Tarkanian during "the troubles" in the late 1980s.

CAREER BACKGROUND

Sam Lionel is a founder of the Lionel Sawyer & Collins. He serves as President of the Firm, is a member of the Executive Committee, and is Chairman of the Litigation Department. He is one of the most respected and well-known trial attorneys in Nevada. His depth of experience and long record of success at trial continues to serve the Firm's prestigious clients.

Lionel is a Fellow of the American College of Trial Lawyers. He is listed in *The Best Lawyers in America* for Bet-the-Company Litigation, Commercial Litigation and Corporate Law, and was named to "The Top 75" by *Mountain States Super Lawyers*. He has an AV rating in the *Martindale-Hubbell* directory. Most recently, *Best Lawyers*, the oldest and most respected peerreview publication in the legal profession, named him as the "Las Vegas Best Lawyers Lawyer of the Year" for 2013 for Bet-the-Company Litigation and in 2010 for Corporate Law.

Lionel was born in New York in 1919. He earned a law degree from St. John's University School of Law in 1940, and was awarded an honorary LL.D. by California Western School of Law in 1985 and an honorary Doctor of Laws from St. John's University in 2010. He was an instructor in the law department at the United States Military Academy. He is a retired lieutenant colonel JAG.
