Clark County Commissioner Chris Giunchigliani

Clark County Commissioner Chris Giunchigliani has lived in Clark County for more than 35 years. During her time here, Chris has become deeply involved in the community as a member of numerous boards, committees and organizations, as well as serving as a member of the State Assembly from 1990 until 2006.

Chris earned a BA degree in special education from Avila College in Kansas City, Mo. in 1976, and later attended UNLV where she earned a Master's degree in education with a special emphasis on the emotionally disturbed. She has also compiled more than 65 additional credit hours in post-graduate work.

Her teaching career began in the Shawnee Mission School District in Kansas, where she taught from 1976 to 1978, and then moved to Clark County to be a special education teacher. Chris was a special education teacher here from 1979 until the summer of 2007. During that time she served eight years as president of the state and local teachers association. She then spent about a year at the Community College of Southern Nevada in School District and Community Relations, before returning to the Clark County School District in 2005 as a special education facilitator and mentor to new teachers at Bridger Middle School. She then went back to teaching at Carroll Johnston Middle School until applying for an unpaid leave of absence in June 2007 after winning election to the Commission. She continues to be on unpaid leave of absence from Clark County School District.

Chris was sworn into a second term of office as County Commissioner for District "E" on January 3, 2011 to serve a four-year term. She was first elected to the Commission in 2007. Chris and her husband Gary Gray have been married since 1987 and live in Las Vegas with their newly rescued and adopted bulldog Otis.
