Agenda Item Title: Extension of President Richards' Contract

Meeting Date: March 6-7, 2014

1. BACKGROUND & POLICY CONTEXT OF ISSUE:

The four year employment contract for President Richards ends June 30, 2015. The Board's Procedures and Guidelines Manual, Ch. 2, Sec. 2.2, requires that the periodic evaluation occur in the year before the contract ends. Periodic evaluations of the performance of institutional presidents normally occur every three years before the end of the contract. The four year contract term for President Richards should be extended to allow for sufficient time to conduct a comprehensive review as multiple reviews are scheduled to occur during this same time period.

2. SPECIFIC ACTIONS BEING RECOMMENDED OR REQUESTED:

The approval of a one year extension to President Richards' employment contract.

3. IMPETUS (WHY NOW?):

Periodic presidential evaluations customarily occur every three years and a one year extension of the contract through June 30, 2016 is requested to allow for adequate time to properly conduct the multiple periodic performance reviews in the year before the contract ends as required by the Board's Procedures and Guidelines Manual, Ch. 2, Sec. 2.2.

4. BULLET POINTS TO SUPPORT REQUEST/RECOMMENDATION:

- A president's periodic performance evaluation normally takes place every three years.
- President Richards' evaluation should take place in the year before the contract ends as required in the Procedures and Guidelines Manual, Ch. 2, Sec. 2.2.
- A one year extension allows for sufficient time to conduct multiple presidential periodic reviews scheduled to occur during the same time period.

6. ALTERNATIVE(S) TO WHAT IS BEING REQUESTED/RECOMMENDED:
