2. BACKGROUND & POLICY CONTEXT OF ISSUE:

UNLV President Len Jessup has been offered an honorary full golf membership (fee waived) at the DragonRidge Country Club in Henderson, Nevada. This potential membership would allow him opportunities to host donors, potential donors, and community members in an elegant setting, and he would be responsible for all carts fees, food, and beverage.

DragonRidge Country Club is located high above the Las Vegas Valley floor in the McCullough Mountains. DragonRidge is a true "Members Course" that is challenging for all skill levels. With unobstructed views of the entire valley, DragonRidge consists of an 18-hole, par 72 layout that stretches to 6,975 yards. The location incorporates innovative use of natural hillsides and canyons, and the topography that makes up DragonRidge and the entire MacDonald Highlands community is breathtaking.

3. SPECIFIC ACTIONS BEING RECOMMENDED OR REQUESTED:

Chancellor Klaich requests approval for UNLV President Len Jessup to receive the honorary full golf membership (fee waived) at the DragonRidge Country Club in Henderson, Nevada. This membership has a value of \$12,500.
