School of Law, UNLV

Meeting Date: June 9-10, 2016

2. BACKGROUND & POLICY CONTEXT OF ISSUE:

On a biennial basis the Board requests that proposals for future tuition and fees for the professional school be reviewed. Upon recommendation by the school, and approval by the UNLV President Len Jessup, a proposal to not increase 2017-2019 tuition and fees for the UNLV William S. Boyd School of Law has been presented. A reference document is attached providing detailed background in support of this recommendation.

3. SPECIFIC ACTIONS BEING RECOMMENDED OR REQUESTED:

UNLV President Len Jessup and Dean Dan Hamilton, UNLV William S. Boyd School of Law, request approval to maintain the current registration fee structure. The UNLV William S. Boyd School of Law is not requesting a registration fee increase for the 2017-2019 biennium.

4. IMPETUS (WHY NOW?):

Consistent with the biennial budget process.

5. BULLET POINTS TO SUPPORT REQUEST/RECOMMENDATION:

- To remain competitive with peer institutions and to attract a high quality student body, the law school will not request a tuition and fee increase in the next biennium.
- Maintaining current tuition and fee levels is consistent with law school trends nationwide given the transition seen in law school applicants.
- The law school will raise additional revenue through increased fundraising and new programs.

6. POTENTIAL ARGUMENTS AGAINST THE REQUEST/RECOMMENDATION:

- Raising tuition and fees would increase revenue for the law school.

7. ALTERNATIVE(S) TO WHAT IS BEING REQUESTED/RECOMMENDED:

- UNLV could request an increase in tuition and fees; however, higher tuition would hurt the law school's ability to compete for top students.

I. Registration Fee and Non-Resident Tuition

The UNLV William S. Boyd School of Law will not raise registration fees for the 2017-19 biennium. The law school's tuition and fees remained flat at \$23,900/year for residents and \$34,900/year for nonresidents from FY12 until FY16. Tuition and fee levels were raised in FY16 to \$24,900/year for residents (an increase of 4.184%) and \$36,300/year (4.011%) for nonresidents. In FY17, the tuition and fee levels will be \$25,900/year (4.016%) for residents and \$37,800/year (4.132%) for nonresidents. Proportionate increases were made to the part time tuition and fees per credit. In FY16, residents were charged \$890 per credit and nonresidents were charged \$1,296 per credit. In FY17, residents will be charged \$926 per credit and nonresidents will be charged \$1,350 per credit.

The law school increased tuition and fees modestly during the 2015-17 biennium to maintain the long-term sustainability of the law program. To remain competitive with peer institutions and to attract a high quality student body, it is not advisable to raise tuition and fees in the next biennium. Instead, the law school will increase revenue through fundraising and new programs.

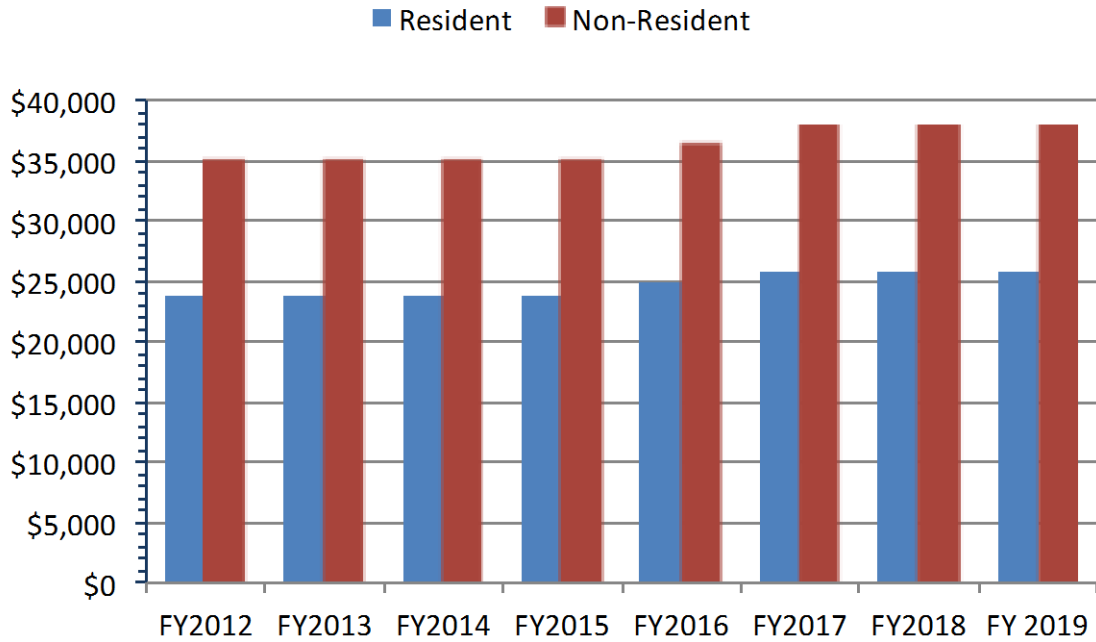
Figure C: Resident and Nonresident Tuition for Peer Schools, FY12-FY16

Figure B: Tuition and Fees



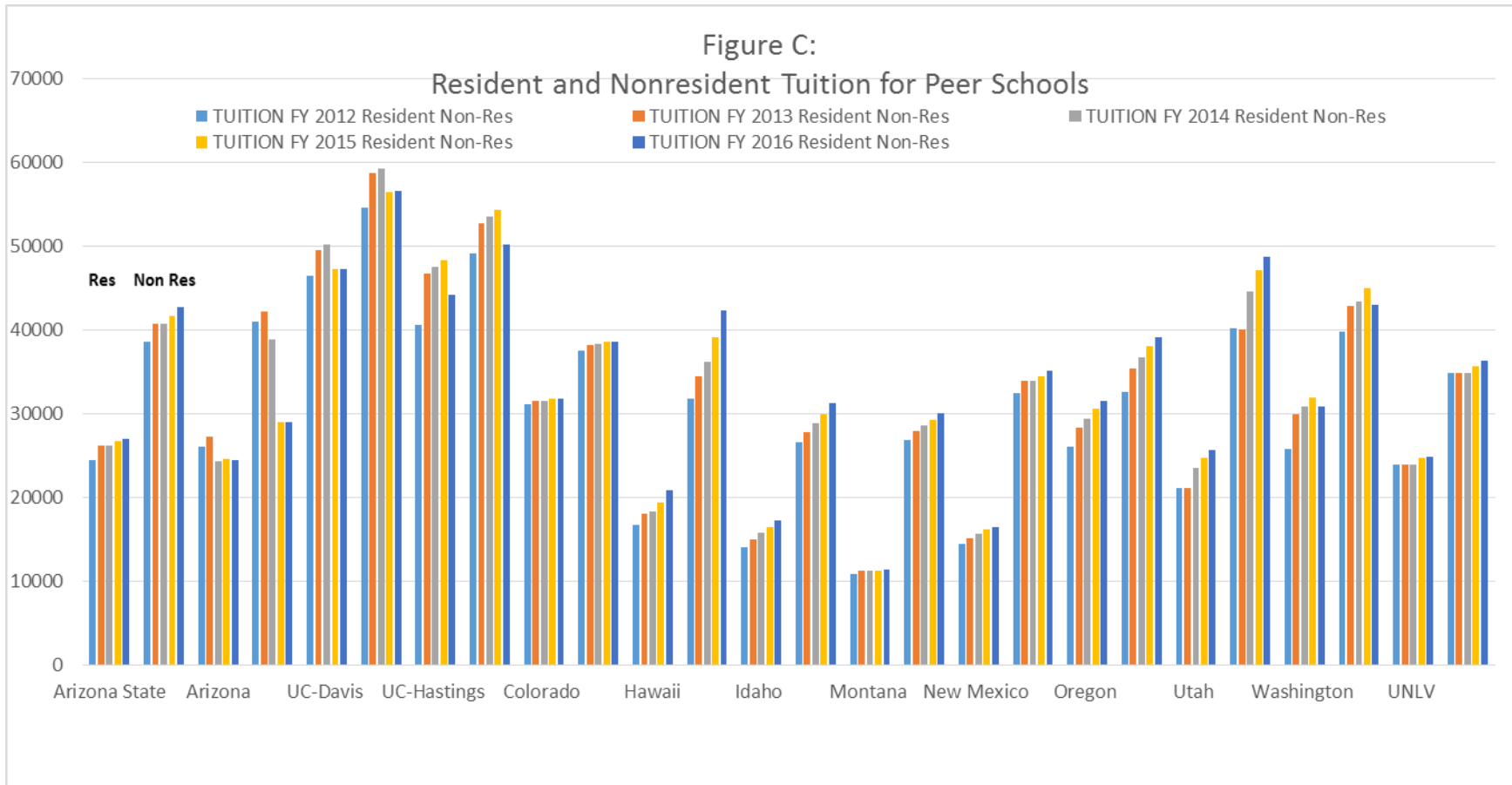
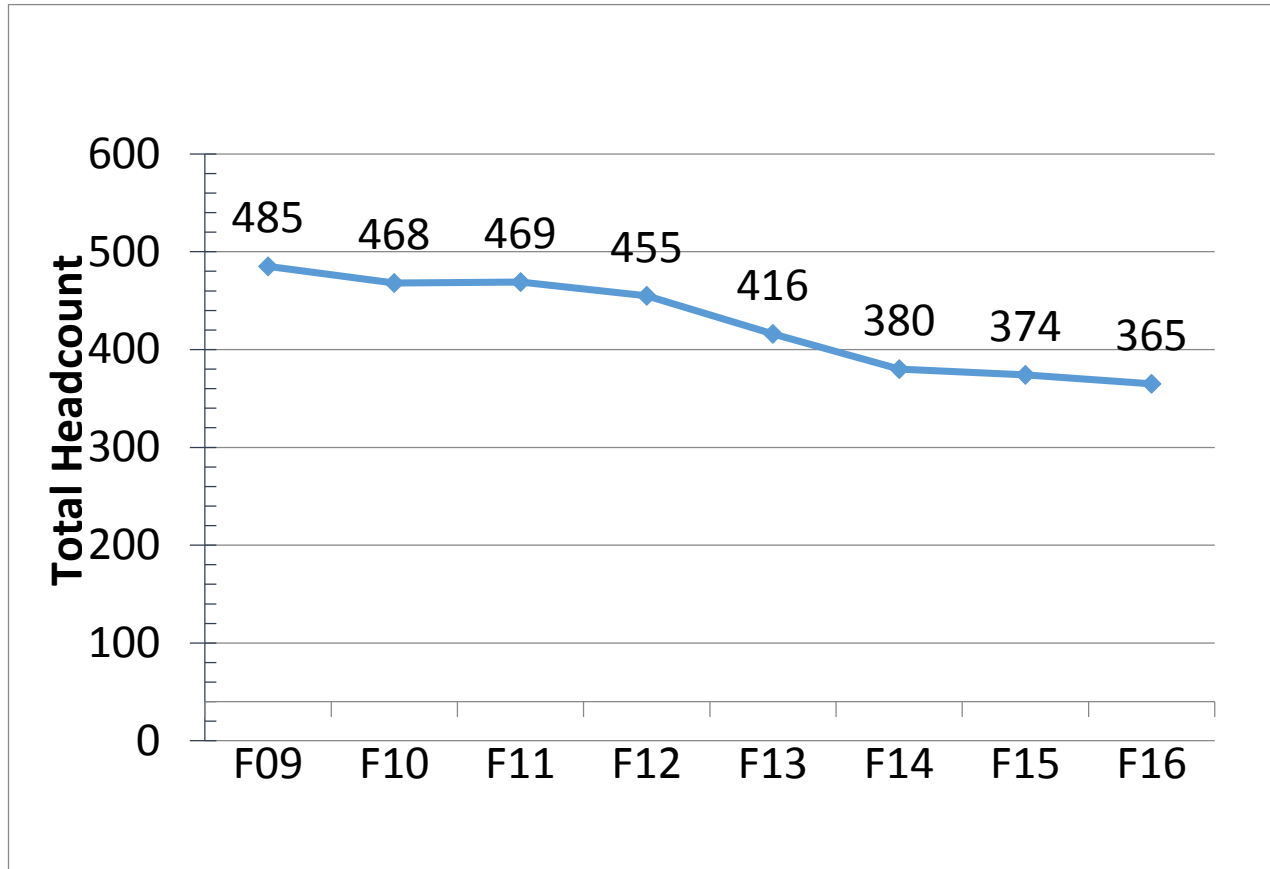


Figure D: Total Law School Enrollment Headcount

CHAPTER 7, SECTION 4

Tuition and Fees, William S. Boyd School of Law

Section 4. Tuition and Fees, William S. Boyd School of Law Students

A. All full-time William S. Boyd School of Law resident and non-resident students shall be assessed annual tuition and registration fees as follows:

B. All part-time William S. Boyd School of Law resident and non-resident students shall be assessed per credit tuition and registration fees as follows:

C. All admitted law students must deposit \$500 to hold the applicant's place in the class. The deadline for this deposit will meet the Law School Admission Council's Statement of Good Admission and Financial Aid Practices requiring admitted students to deposit no sooner than April 1. If the entering law student's offer of admission has come after March 1, the admitted law student will be required to deposit within one month of acceptance for admission. The deposit will be applied toward tuition and is not refundable. A second \$500 non refundable deposit will be due June 10 for all admitted law students who were accepted prior to May 10 and who paid the initial \$500 deposit. This second non refundable deposit is required to continue to hold the applicant's place in the class. Both of these deposits will be applied toward registration fees and/or tuition. All admitted law students accepted after May 10 must, according to the date specified in the acceptance packet for admission, make a \$1,000 non refundable deposit to hold the applicant's place in the class. This deposit is required to hold the applicant's place in the class and will be applied toward registration fees and/or tuition.

D. All William S. Boyd School of Law resident and non-resident students shall be assessed per credit tuition and registration fees for Summer term courses as follows:
