I. Additional Institutions

The following charts provide a snapshot of how the University of Nevada and UNLV would currently compare to the additional institutions which were excluded within the original benchmarking sample from the Big 12 and Pac-12. These include Oklahoma and Texas from the Big 12; UCLA, USC, Oregon and Stanford from the Pac-12. These institutions have unique attributes related to revenue streams, expense budgets, and/or market size that differentiate them substantially from their fellow conference members, and, in the case of the two private schools (USC and Stanford), information relative to revenue and expense is not available in the same manner as the public schools.





B. Student Enrollment




Full-Time Enrollment Undergraduate, Graduate & First Professional Degree (Fall 2014)


C. Full-Time Instructional Staff with Faculty Status






B. Graduation Success Rate (GSR)





B. Sport Sponsorship









B. Major Expense Categories








Men's Basketball Expenses (FY15)



A. Total Athletic Revenues





B. Allocated Revenues







Contributions (FY15)














Facilities A. Football Attendance/Capacity





2015 Average Home Football Attendance



Football- % of Capacity Filled




