## **BOARD OF REGENTS BRIEFING PAPER**

1. Agenda Item Title: UNR and UNLV Athletic Department Budget Updates. Meeting Date: February 23, 2017 meeting of the Committee on Athletics

## 2. BACKGROUND & POLICY CONTEXT OF ISSUE:

In September of 2016 the Committee reviewed the annual reports submitted by the UNR and UNLV athletic departments as provided in Title 4, Chapter 24, Section 1, Subsection 9 of the Handbook - copies of which are attached as **Exhibits A and B** respectively.

At that time concerns were raised about the budgets for both athletic departments including possible line item and operating deficits. This agenda item will serve as an opportunity for the institutions to update the Committee on their athletic department budgets including performance to date for FY2017 (on a cash basis). To the extent a deficit is shown or expected within any line item or with the overall operating budget, the institutions will provide a plan for addressing the deficit. In addition, the institutions will present, and the Committee will review and discuss, reports from the institutions showing budget to actual for the past three fiscal years (on a cash basis). Copies of the reports submitted by UNR and UNLV responsive to this agenda item are attached as **Exhibit C** and **D** respectively. Finally, the Committee may provide direction to the institutions regarding the current athletic department budgets for FY2017 and the formation of the athletic department budgets for FY2018.

The Committee on Athletics will review and discuss the performance to date of the UNR and UNLV athletic department budgets for FY2017.
